## *Biographical notes*

### Mr Roy Warden

I arrived at Trinity Hall in October 1973 on the day Egypt and Syria invaded Israel to start the Yom Kippur War. For an undergraduate reading History, it was thoughtful of the College to provide so many study opportunities. While I was up, there was a global oil crisis, a miners' strike in the UK, and an enforced three day week. I voted in two General Elections, and in a referendum on the UK's membership of the European Union. In the US, the Watergate crisis rumbled on and in August 1974 President Nixon resigned. In the same year, Trinity Hall's Governing Body voted to admit women, although the first female fellows and graduate students did not arrive until 1976 as I was leaving.

After graduating, I spent 40 years in tax administration, variously in the Inland Revenue, HM Treasury and HM Revenue and Customs. Much of this involved the taxation of business profits, on which I have represented the UK at the OECD and in the EU. Along the way, I picked up an MSc in public finance and leadership from Warwick University and I became a qualified accountant with the Chartered Institute of Public Finance and Accounting.

Keeping in touch with Trinity Hall is something which, for me, has fluctuated between enthusiasm and benign neglect as life and career events unfolded. I have enjoyed being a Year Rep, but I cannot say I have had to work very hard at it. I will have a great opportunity to contribute to the THA committee, particularly as Finance Officer, after I leave HMRC on 22 September 2016. Regrettably, I will not be able to be at the AGM or Annual Dinner as that morning my wife and I are boarding a flight to Boston to spend time in New England during the Fall.

### Dr Emma Bailey

Hi, my name is Emma Bailey and I matriculated at Trinity Hall in 2009. I originally came from Kent and studied the IB, before coming to Cambridge to study Medicine. I did both my Undergrad and Clinical years based around East Anglia, and graduated in 2015. During my time at Trinity Hall I was on the JCR committee as Welfare Officer and helped out with events for Fresher's Week and other Welfare Events during the year. I was a Peer Supporter in college and helped with the adaptation from a Counselling Service based regime to a student run organisation. I was also captain of the girls' hockey team – and attempted to get a full team each week! I am now working as a doctor/SHO in Bedford Hospital.

I read French and Spanish and UCL, Economics at Trinity Hall (92) as a graduate, and holds an MBA from Imperial College. I very much enjoyed my time at Trinity Hall and try to attend events there whenever possible. I then worked in academic, educational and professional publishing in Europe and the Middle East, and for e-learning companies and digital publishing businesses before starting a conference business and organising art exhibitions. I live in Cambridge and London. Quite a lot of my conference work is focused on bridging the gap between research at Cambridge University and the wider worlds of industry, government and the media and I hope that this experience could be relevant to THA (some of the TH Fellowship have participated in the conferences).
