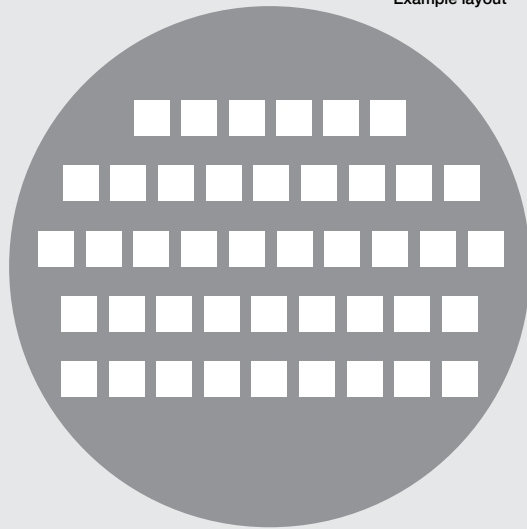


# Take a seat...
