### Notes to the financial statements

1. The Trinity Hall Association benefits from a generous endowment made in 2004 which is administered by the College (Trinity Hall) on behalf of the Association. An audit of the endowment is included in the audit of the College accounts.
2. The value of the endowment held by the College on behalf of the Association at 30 June 2020 was £733,893. The value at 30 June 2019 was £800,940.
3. In the year to 30 June 2020, the Association incurred costs of £4,800 (31% of total costs) in defending a legal claim and further costs will be incurred as the case is not yet resolved. The committee will seek to keep these costs to a reasonable amount and to reclaim costs if there is an opportunity.
4. In the year to 30 June 2020, the Association paid a deposit of £2,394 to the caterers for an event due to take place in Edinburgh in November 2020. In early August, we were informed that the company had gone into administration. We have filed a claim with the administrator, but we do not yet know what amount, if any, we will be able to recover.
